

### Privacy Policy - V1.0

## 1. Introduction

This privacy notice provides you with details of how we collect and process your personal date through your use of our site <u>www.michelleturpin-coach.co.uk</u>, including any information you may provide through your site when you purchase a product or service, sign up to our newsletter or take part in a prize drawer competition.

By providing us with your date, you warrant to us that you are over 13 years of age.

**Michelle Turpin** is the data controller, and we are responsible for your personal data (referred to as "we", "us" or "our" in this privacy notice).

If you are not happy with any aspect of how we collect and use your data, you have the right to complain to the Information Commissioner's Office (ICO), the UK supervisory authority for data protection issues (<u>www.ico.org.uk</u>). We should be grateful if you would contact us in the first instance if you do have a complaint so that we can try to resolve it for you.

It is very important that the information we hold about you is accurate and up to date. You can let us know if at any time your personal information changes by emailing us at <u>info@michelleturpin-coach.co.uk</u> to update your details.

## 2. What data do we collect about you?

Personal data means any information capable of identifying an individual. It does not include anonymised data.

We may process certain types of personal data about you as follows:

- Identity Data may include your first name, maiden name, last name, username, marital status, title, date of birth and gender.
- **Contact Data** may include your billing address, delivery or shipping address, email address and telephone numbers.
- Financial Data may include your bank account and payment card details.
- **Transaction Data** may include details about payments between us and other details of purchased made by you.
- **Technical Data** may include details about your login data, internet protocol addresses, browser type and version, browser plug-in types and versions, time zone setting and location, operating system and platform and other technology on the devices you use to access this site.
- **Profile Data** may include your username and password, purchases or orders, your interests, preferences, feedback and survey responses.
- Usage Data may include information about how you use our website, products, and services.
- Marketing and Communications Data may include your preferences in receiving marketing communications from us and our third parties and your communication preferences.

We may also process **Aggregated Data** from your personal data, but hits data doe does not reveal your identity and as such in itself is not personal data. An example of this is where we review your usage data to work out the percentage of website users using a specific feature of our site. If we link the **Aggregated Data** with your personal data so that you can be identified from it, this it is treated as **Personal Data**.

#### Sensitive Data

Sensitive data refers to data that include details about your race or ethnicity, religious or philosophical beliefs, sex life, sexual orientation, political opinions, trade union membership, information about your health and genetic and biometric data. We will only collect Sensitive Data from you if you explicitly consent to us doing so.

## 3. How we collect your personal data

We collect data about you through a variety of different methods including:

- **Direct interactions:** You may provide data by filling in forms either at an event or on site or by communicating with us by pose, telephone, email or otherwise, including when you
  - Order our products of service
  - Create an account on our site
  - Subscribe to our service(s) or publications
  - Request resources or marketing to be sent to you
  - Enter a completion, prize draw, promotion or survey
  - Provide us with feedback
- Automated technologies or interactions: As you user our site, we may automatically collect Technical Data about your equipment, browsing actions and usage patterns. We collect this date by using cookies, server logs and similar technologies. We may also receive Technical Data about you if you visit other websites that use our cookies. Please see our cookie policy for further details.
- Third parties or publicly available sources: We may receive personal data about you from various third parties and public sources as set out below:
  - Technical Data from the following parties:
  - analytics providers such as Google based outside the EU;
  - $\circ\;$  advertising networks such as Facebook Ads and Google Ads based outside the EU; and
  - $\circ$  search information providers such as Google based outside the EU.
  - Contact, Financial and Transaction Data from providers of technical, payment and delivery services such as PayPal based outside the EU.
  - Identity and Contact Data from publicly availably sources such as Companies House and the Electoral Register based inside the EU.

### 4. How we use your personal data

We will only user your personal data when legally permitted. The most common uses of your personal data are:

- Where we need to perform the contract between us.
- Where it is necessary for our legitimate interests (or those of a third party) and your interests and fundamental rights do not override those interests.
- Where we need to comply with a legal or regulatory obligation.

Generally, we do not rely on consent as a legal ground for processing your personal data, other than in relation to sending marketing communications to you via email or text message. You have the right to withdraw consent to marketing at any time by emailing us at info@michelleturpin-coach.co.uk.

#### Purposes for processing your personal data

Set out below is a description of the ways we intend to use your personal data and the legal grounds on which we will process such data. We have also explained what our legitimate interests are where relevant.

We may process your personal data for more than one lawful ground, depending on the specific purpose for which we are using your data. #### Marketing communications

You will receive marketing communications from us if you have:

- Requested information from us or purchased goods or services from us.
- If you provided us with your details for us to send you marketing communications
- If you have not opted out of receiving that marketing.

We will get your express opt-in consent before we share your personal details with any third party for marketing purposes.

You can ask us or any third parties to stop sending you marketing messages at any time by following the opt-out links on any marketing messages sent to you or by emailing us at <u>info@michelleturpin-coach.co.uk</u> at any time.

Where you opt out of receiving our marketing communications this will not apply to personal data provided to us as a result of a product or service purchase, warranty registration, produce/service experience or other transactions.

#### Change of purpose

We will only use your personal data for the purposes for which we collected it, unless we reasonably consider that we need to use if for another reason and that reason is compatible with the original purpose. If you wish to find out more about how the processing for the new purpose is compatible with the original purpose, please email us at info@michelleturpin-coach.co.uk.

If we need to use your personal data for a purpose unrelated to the purpose for which we collected the data, we will notify you and we will explain he legal basis for processing.

We may process your personal data without your knowledge or consent where this is required or permitted by law.

## 5. Disclosures of your personal data

We may have to share your personal data with the parties set out below for the purposes as explained in the table in section 4 above:

- Service providers who provide IT and system administration services.
- Professional advisers including lawyers, bankers, auditors and insurers who provide consultancy, banking, legal, insurance and accounting services.
- HMRC, regulators and other authorities based in the UK who require reporting of processing activities in certain circumstances.
- Third parties to whom we may sell, transfer, or merge parts of our business or our assets.

We require all third parties to whom we transfer your data to respect the security of your personal data and to treat it in accordance with the law. We only allow such third parties to process your personal data for specific purposes and in accordance with our instructions.

# 6. Data Security

We have put in place appropriate security measures to prevent your personal data from being accidentally lost, used or accessed in an unauthorised way, altered or disclosed. In addition, we limit access to your personal data to those employees, agents, contractors and other third parties who have a business need to know such data. They will only process your personal data on our instructions, and they are subject to a duty of confidentiality.

We have put in place procedure to deal with any suspected personal data breach and will notify you and any applicable regulator of a breach where we are legally required to do so.

# 7. Data Retention

We will only retain your personal data for as long as necessary to fulfil the purposes we collected if for, including for the purposes of satisfying any legal, accounting or reporting requirements.

To determine the appropriate retention period for personal data, we consider the amount, nature and sensitivity of the personal data, the potential risk of harm from

unauthorised use or disclosure of your personal data, the purposes for which we process your personal data and whether we can achieve those purposes though other means, and the applicable legal requirements.

By law we must keep basic information about out customers (including contact, identity, financial and transaction data) for six years after they cease being customers for tax purposes.

In some circumstances you can ask us to delete your data – see below for more information.

In some circumstances we may anonymise your personal data (so that it can no longer be associated with you) for research or statistical purposes in which case we may use this information indefinitely without further notice to you.

### 8. Your Legal Rights

Under certain circumstances, you have rights under data protection laws in relation to your personal data. These rights include:

- The right to request access to your personal data.
- The right to request correction of your personal data.
- The right to request erasure of your personal data.
- The right to object to processing of your personal data.
- The right to request restriction of processing your personal data.
- The right to request transfer of your personal data.
- The right to withdraw consent.

You will not have to pay a fee to access your personal data (or to exercise any of the other rights). However, we may charge a reasonable fee if your request is clearly unfounded, repetitive or excessive. Alternatively, we may refuse to comply with your request in these circumstances.

We may need to request specific information from you to help us confirm your identity and ensure your right to access your personal data (or to exercise any of your other rights). This is a security measure to ensure that personal data is not disclosed to any person who has no right to receive it. We may also contact you to ask you for further information in relation to your request to speed up our response. We try to respond to all legitimate requests within one month. Occasionally it may take us longer than a month if your request is particularly complex or you have made a number of requests. In this case, we will notify you and keep you updated.

# 9. Third Party Links

Our website may include links to third party websites, plug-ins and applications. Clicking on those links or enabling those connections may allow third parties to collect or share data about you. We do not control these third party websites and are not responsible for their privacy statements. When you leave our website, we encourage you to read the privacy notice of every website you visit.

# 10. Cookies

You can set your browser to refuse all or some browser cookies, or to alert you when websites set or access cookies. If you disable or refuse cookies, please note that some parts of the website may become inaccessible or not function properly. For more information, please see the cookie policy.
